Jim Lester from Washington County discussed the process he went through to get EMS as an essential service in both Wright and Washington County. Jim mentioned a shared roster with in the Washington County since there was only three transporting service. The certified care providers didn't have to worry about licensing issue when getting in another jurisdiction's service vehicle.

Scadden discussed getting the service budget plans done and emailed to her.

The Priority/needs started off with Scadden clarifying to stay as individual services and not combining to a county wide service. The discussion was led to creating a list: staffing was the priority. Followed by education with initial certification and continuing education, along with training equipment. The third priority was capital equipment, for example: service vehicles, cardiac monitors/AEDs, cots, etc. The last priority was decided on was operating cost like insurance for services.

Johnson created an EMS Essential Service Education material to help educate the public.

Scaddan encouraged services to work with local partnerships using the same material.

Scadden discussed reaching out to media sources early September.

Scadden and Van Egmond plan on meeting with Tama County Economic Development.

Johnson will be reaching out to a printing company to get a quote for printing the education materials.
